Open Limited and Amateur Limited Gun are retrieving stakes. The retrieving portion of these stakes will consist of a bird field located at the end of the course. Quail and/or Chukar released in all stakes, except puppy. A blank cartridge will <u>not be fired</u> in Open Puppy. Horseback handling is permitted in all stakes. Grounds
