Important Information:

- Travel with all CURRENT HEALTH RECORDS for all animals as required by law.
- This is a walking test. No horseback handling. Judging will be by horseback, walking, or UTV/ATV.
- The test will be run under Flexible format.
- The club reserves the right to rearrange the running order and/or rearrange judges if circumstances require the stated plan be altered.
- Bitches in season will not be allowed to compete, unless accommodation can be made to run as last brace without a male dog.
- For any retrieving competition, handlers, judges, and gallery must wear blaze orange as required by AKC.
- Entrants are responsible for complete and accurate information when entering.
Entries must be complete with AKC Registration number. If pending number, enter "Pending" on form and contact Field Trial Secretary promptly

with the number when received. Invalid or incomplete entries will not be drawn.

- Directions: From Allentown: Take Balls Ferry Road (112) NE for 14.3 miles to Toombsboro Road and turn Right. Continue for 3.3 miles to Old Toombsboro Road , another 0.2 miles. Then turn Left on Oconee Church Road for 1.6 miles to the site.
- From Dublin: Take 441 North for 4.2 miles to Old Toombsboro Road and make a slight right for 5.3 miles. Turn right onto Oconee Church Rd and proceed for 3.2 miles to the site.
- Camping: Camping is permitted on the grounds. There is no dump facility. We will need to locate a water source.
- Water and Toilet Facilities: Porta Potties and non-potable water will be available. Bring personal water.
- Cleanup: Please help keep grounds in good condition by filling your holes and scattering manure prior to leaving. Please drive only on designated areas.
- Meals: TBD
- Motels: multiple motels are available in Dublin, GA

A blank cartridge will be fired in Junior, Senior and Master Hunter. Gunners in Senior and Master Hunters.

Bird and Courses: The Course will be a single course without a designated bird field. Only approved starter pistols may be used. All live shooting in master and senior tests will be done by official gunners. Handlers in the master test will be required to carry an unloaded or "imitation" long barreled gun. Handlers and gallery members in the master and senior braces will be required to wear blaze orange.

Native and liberated quail in all stakes.

Retrieve will be done on course.

Run Time: A minimum of 15 minutes shall be allowed for each brace in the Junior Hunting Test, and at least 30 minutes allowed for each brace in Senior and Master Hunting Tests.

Notice:

Use of AKC approved tracking collars will be permitted. Garmin Wrist Watch, Cell Phone applications or other similar devices will NOT be allowed, or permitted. All receivers (including associated Garmin Watches, cell phone applications, or other tracking devices) will be controlled by the Judges and or Hunt Test Marshall. Activating any of these devices will result in elimination from contention.

Any dog located by tracking collar will not advance.

In consideration for receiving permission to be on premises at the German Shorthaired Pointer Club of Atlanta ("The Club") Field Trial held at Beaverdam Wildlife Refuge in Dublin, Georgia, I, on behalf of myself and any minor child/children for whom I have the capacity to contract, hereby acknowledge and agree to the following:

I shall indemnify, defend and hold harmless the Releasees from and against any and all claims, demands, suits, judgments, losses or expenses of any nature whatsoever (including, but not limited to attorneys' fees, costs and disbursements, whether of in-house or outside counsel and whether or not an action is brought, on appeal or otherwise), arising from or out of , or related to, directly or indirectly, any infection or other illness or injury.

It is my express intent that this Waiver and Hold Harmless Agreement shall bind any assigns and representatives, and shall be deemed as a RELEASE, WAIVER, DISCHARGE, AND COVENANT NOT TO SUE The Club, its officers or members, and the landowner. This agreement and the provisions contained herein shall be construed, interpreted and controlled according to the laws of the State of Georgia. I HEREBY KNOWINGLY AND VOLUNTARILY WAIVE ANY RIGHT TO A JURY TRIAL OF ANY DISPUTE ARISING IN CONNECTION WITH THIS AGREEMENT. I ACKNOWLEDGE THAT THIS WAIVER WAS EXPRESSLY NEGOTIATED AND IS A MATERIAL INDUCEMENT. THE PERMISSION GRANTED HEREBY RELEASES THE PARTICIPANT TO BE ON PREMISES AND PARTICIPATE AT THEIR OWN RISK IN THE ACTIVITIES.
