Quail, chukar, pigeons and/or pheasants will be released in all stakes except Open Puppy. All stakes are single course without a bird field. Horseback handling will NOT be permitted in all stakes. A blank cartridge will be fired in all stakes except Open Puppy. All stakes are non-retrieving.

SCRATCH POLICY AFTER CLOSING DATE

Entries will be refunded in full only for dogs that have an injury or illness that prevents running in the registered stake or that are deceased prior to running in the registered stake. Club may require an appropriate veterinary certificate.



Directions to Racetrack Trial Grounds: From I-90 in Billings take the 27th St. exit. Turn north onto 27th St. and follow it to the top of the hill heading towards the Billings airport. At the top of the hill, you will hit a roundabout. Go left through the roundabout onto Highway 3 towards (Broadview) and Acton. Acton is about 14 miles northwest of Billings. At the small town of Acton, turn left onto Mainwaring Rd. Go about 3 miles west and follow the signs to the trial grounds on the left. If you get to the Yellowstone Drag Strip gate, you have gone too far. **Map: The trial grounds are on the blue (State Land). Section 16, R2N, T24E. Waypoint: 45.92606, -108.74489**
