**DIRECTIONS:Directions:**

From the North or South, NJ Turnpike to EXIT 5. Turn RIGHT onto Route #541 after toll. Take Route 541 towards Mt. Holly. Turn RIGHT onto Mt. Holly BY-PASS (at Burger King) towards Route 38. Go straight across Rt. 38 and at next light turn RIGHT onto Route #541. Follow Rt. 541 south through Lumberton towards Medford. Turn RIGHT after the Bob Bende Soccer Park onto dirt drive. Watch for English Setter Club sign and field trial arrows at driveway. Proceed SLOWLY down lane. Please travel with current health certificates on all animals.
